**Official Rules**

No Purchase or Contribution Necessary to Enter or Win

1. Eligibility: This Drawing by Chance is offered to anyone at least 18 years old. By registering you agree that you would like to receive more information about the Miami-Dade County Fair & Exposition, Inc. and its affiliated partners. (You may opt-out of the receipt of such information at any time).
