Official Rules

No Purchase or Contribution Necessary to Enter or Win

1. Eligibility: This contest is offered to anyone at least 18 years old. Employees, Officers and Directors of the Miami Dade County Fair & Exposition, Inc., ("The Youth Fair"), as well as participating prize provider(s), affiliated and subsidiary companies and their advertising and promotional agencies and the immediate family (spouse, mother, father, sister, brother, daughter or son, regardless of where they live) or members of the households of such Employees, Officers and Directors and (whether or not related) are not eligible. By entering, you agree to these Official Rules and the decisions of The Youth Fair, which are final and binding in all respects.

2. Promotional Period: Participants can submit their forms starting on February 20, 2017 at 9:00 a.m. Eastern Time (EST), through March 10, 2017 at 11:59 p.m. (EST). Photos will be uploaded to The Youth Fair Facebook page starting March 13, 2017 and participants will compete for "likes" through March 17, 2017. ("Promotional Period").

3. Entry: No purchase or contribution is necessary. To enter, submit a photo and complete an entry form with your legal name, email address and cell phone number. Only one entry per person. By registering you agree that you would like to receive more information about the Miami-Dade County Fair & Exposition, Inc. and its affiliated partners. (You may opt-out of the receipt of such information at any time).

No responsibility is assumed for lost, late, incomplete, stolen, misdirected, or illegible entries; or for any computer, telephone, cable, network, electronic or Internet hardware or software malfunctions, failures, connections, availability or garbled or jumbled transmissions, service provider/Internet/web site/use net accessibility or availability, traffic congestion, or technical failures, or unauthorized human intervention, or the incorrect or inaccurate capture of entry or other information, or the failure to capture any such information.
